# **Synor 2009**

Provincial Synod will begin in the next 3 days in St. Kitts (July 10, 2009). The Synod is the highest authority in the Province, with supreme legislative powers in all matters not committed to the Unity Synod. The duties and powers of the Provincial Synod shall be:

- To carry out and give effect to the principles of the Moravian Church as laid down by the Unity Synod of Constitution, Doctrine, Worship and Congregational life.
- The power of legislation touching Constitution, Worship and Congregational life.
- To settle the Provincial undertakings and fields of work; the giving up of existing and the taking in hand of new fields of work; the admission of or the giving up of congregations.
- Election of members of the Provincial Elders' Conference (PEC); election of members of Provincial committees.
- Oversight of the undertakings carried on in the name of the Province as a whole.
- ◆ Election of Bishops of the Moravian Church.
- Election of Delegate(s) to Unity Synod.

◆ Discharge of tasks which fall to Synod as a Court of Appeal.

The Provincial Synod is responsible to Unity Synod for the principles on which it adopts resolutions and supervises its Executive Board and undertakings. The resolutions of the Provincial Synod are binding on all boards, congregations, Ministers and individual members in the Province. Notice of constitutional changes affecting the synod or the administration of the Province must be given to the PEC at least three months prior to the date of the Synod.

The Chairman and members of PEC welcome all delegates and observers to this 29<sup>th</sup> Provincial Synod. Let us determine to seek God's face and place our hands into his hands. Let us commit this time to prayer and fasting as we journey ahead.

The St. Kitts Conference has been working assiduously to make sure that all goes well for this very important Synod. Thank you very much St. Kitts, we look forward to a wonderful, spirit-filled experience. We come with the words of scripture as enunciated in Lamentation. 3: 22-23 "The steadfast love of the LORD never ceases; his mercies never come to an end; they are new every morning; great is your faithfulness".

# Women Priests in the Moravian Church in 1758

During an ordination service in Herrnhut on May 12th 1758, three women were ordained as "priestesses" or presbyters of the M or a v i a n C h u r c h: Elizabeth Layritz, Marie von Zinzendorf, and Magdelena Vierorth. It was a memorable ordination service during which not only the three priestesses but also eighteen deconesses, twenty-seven deacons, six priests (presbyters) and two (male) bishops were ordained.

The ordination of women was unheard of in the 18th century. Even today, some Christian religious groups do not allow women to be ordained, based on Paul's admonition that "women should be silent in the churches" (1Cor. 14:34). Zinzendorf, leader of the Moravians, however, interpreted the bible text as being intended for the situation in Corinth and he did allow women a much more prominent religious role.

In 1745 Count Zinzendorf decided to ordain a group of 20 women as deconesses and in the years to follow many other women were ordained as well. Zinzendorf was influenced by other radical Priests such as Gottfried Arnold, who in his widely read publications had demonstrated the existence of "diaconissas" and "presbyteriae" in the early Christian church.

In 1745 the Moravian Church adopted the system of various degrees of pastoral service from the

Ancient Unity: acolytes, decons, presbyters, and bishops. Acolytes were unordained ministerial helpers, whereas deacons, presbyters, and bishops were members of the ordained ministry. From the beginning women were accepted as acolytes as well as ordained deacons. It seems that Zinzendorf intended to consecrate women as presbyters, although he was hesitant to do so in public. During the ceremony on May 12th 1758, Zinzendorf announced he had ordained other priestesses in the previous years, however without making these events public. Even among Moravians the prominent role women played was controversial; in many cases Zinzendorf had to defend this policy before the other leaders of the church. During the service on May 12th Zinzendorf declared: "The sisters

Also have a right to the priest-hood. They have among themselves and in their capacity the same three first degrees of the congregational offices [acolytes, deacons, and presbyters] as the brethren." As they knelt, Zinzendorf and Anna Nitchsmann laid their hands on the sisters heads and consecrated the three women as priestesses while the choir sang a doxology that has since remained part of every Moravian ordination service (Glory Be to Thy Most Holy Priesthood").

What were the responsibilities of ordained women in the early Moravian Church? Ordained women were allowed to perform pastoral services within their respective choirs and to give an address in meetings with only women present; they also assisted in the dis-

tribution of Holy Communion, and some of them (the so-called archdeaconesses) even performed ordinations of other women. The office of the archdeaconesses came closest to that of a male bishop. Although the women's responsibilities were confined to the female realm and therefore not equal to those of their male counterparts, their roles were quite extraordinary when compared with other groups of the time.

Zinzendorf's successors did not approve of women in prominent leadership roles. Although the ordination of deaconesses continued until 1790, female presbyters were no longer consecrated. Women continued their service to the church, although they played their roles not as openly as when Zinzendorf was still alive. It would not be until 1967 when a Moravian woman was ordained again in Dresden, Germany.

#### **Unity Synod**

On Monday 27 July, people from all over the Moravian Unity will be flying into Heathrow and Gatwick

bound for High Leigh Conference Centre, Hoddesdon, Herts. Three people from each full Unity Province, one from each Affiliated Province, and Unity Undertaking along with representatives of the bishops, the women's steering committee, the theological standing committee and the youth steering committee.

In Total there will be 70 synodals meeting together for two weeks at

High Leigh. The reason that the synod lasts so long is that much of the time is spent in committee. Each synodal will be a member of one of the following committees: Finance, Ministry, Mission & Unity affairs, Constitutional matters, Church in Society. Proposals are referred to the committees for further work and redrafting. They are then brought back to the plenary and can possibly be referred back for even more work.

It is extremely hard to forecast the number of events and delegations that will be needed during the forthcoming seven year period. This Synod will have at least 10 more delegates than the last one.

The business will be conducted in English and there will be a translator for those Spanish speakers who need some help in this area.

There are very few churches that have an international legislature and it takes a real commitment to the Unity to bind oneself and one's province to the decisions taken by such a diverse body. Yet this is a distinctive aspect of what it means to be a Moravian: a willingness to discern together God's will for his church.

The theme for the Synod is "Discerning God's mission through our Unity" and, for the first time, a designated chaplain has been appointed to coordinate daily worship and Bible Study and we are pleased that Sis. Angeline Swart, immediate past President of the Unity Board has accepted this invitation. Sis. Beth Torkington will be preaching at the opening service and we look forward to her message for us on that day.

The middle weekend will be free of business. Delegates will be on a tour of London on the Saturday. On the Sunday, there will be a service at High Leigh in the morning and then coaches will take everyone who so chooses to Chelsea to visit the Close.

So, we look forward to a fortnight of

hardwork interspersed with times of relaxation and fellowship, of getting to know brothers and sisters from many different places and backgrounds, of moving more closely towards being the mutually accountable, inclusive body of Christ that we aspire to be.

Sisters Winelle Kirton-Roberts and Jeanette Smith-Barry, along with Brother Cortroy Jarvis will represent the Eastern West Indies Province at this Synod. In addition, Bishop Kingsley Lewis will represent the Bishops at the Synod.

Please lift up the Unity Synod in your prayers, that Synod might indeed discern God's mission through our Moravian Unity and that, through Synod, the wider church may be truly blessed.

## MORAVIAN NAMED BY PRESIDENT OBAMA TO KEY POSITIONS.

On May 1, 2009, President Obama announced his intent to nominate Wilma A. Lewis, as Assistant Secretary for Land and Mineral Management, Department of the Interior.

Wilma A. Lewis is Chair of the Board for Moravian Theological Seminary and is also a board member of Faith Moravian Church in Washington, D.C. She has extensive litigation experience with federal trial and appellate complex civil litigation, including class actions as well as internal investigations. Lewis served as Managing Associate General Counsel with Freddie Mac from October 2007 to December 2008 and was a partner at Crowell & Moring from June 2001 to September 2007. She served as the United States Attorney for the District of Columbia - the first woman appointed by the President to serve in that capacity - from January 1998 to April 2001.

During her tenure, she led the largest U.S. Attorney's Office in the country, with responsibility for most federal and local criminal investigations and

prosecutions, and most federal civil proceedings on behalf of the United States in the Nation's Capital. From April 1995 to January 1998, she served as Inspector General for the U.S. Department of the Interior – the first African-American to hold that position – where she oversaw investigative and audit activities designed to ferret our fraud, waste and mismanagement in Department of the interior programs and operations. Lewis' public service also included her tenure as an Assistant United States Attorney for the District of Columbia (1986 - 1993), where she attained the position of Deputy Chief of the Civil Division, and as Associate Solicitor for the Division of General Law at the U.S. Department of the Interior (1993 - 1995). Before entering public service, Lewis served as an Associate in the General Litigation Group at Washington, D.C. law firm of Steptoe & Johnson (1981 – 1986). Lewis is a member of the District of Columbia Bar Association and is also admitted to practice before the U.D. District Court for the District of Columbia, the U.D. Court of Appeals for the District of Columbia Circuit, U.S. Court of Appeals for the Fourth Circuit, and the Supreme Court of the United States. In 2003, the Harvard Law Bulletin featured Lewis as one of 50 female graduates of Harvard Law School who have used their legal education "to take them to extraordinary places." Lewis earned a Bachelor of Arts degree with distinction from Swarthmore College in 1978, where she was elected to Phi Beta Kappa, and a Juris Doctor degree from Harvard Law School in 1981. She is a native of the U.S.

Sis. Wilma A. Lewis is also a member of the Memorial Moravian Church in St. Thomas, USVI. The Province extends heartiest congratulations to her and extends God's richest blessings in this new appointment.
